**WHEREAS “P. Rami Reddy Memorial College of Pharmacy”** wishes to its sustainability to enable the responsible disposal of solid recyclables during the period 23 of august 2022

**NOW Therefore**, in consideration of the a foresaid and the mutual promises between the parties under this Agreement, the parties here to agree as follows:

**1. Now This MOU Witnessed as Under:**

This is an agreement for a synergic alliance between “**P. Rami Reddy Memorial College of Pharmacy**” and **Kadapa Municipal corporation** for the cause of recycling of Solid waste and to protect environment, conserve natural resources, inculcate the habit of source segregation among the citizens, recover and recycle the solid recyclables which is going to landfill and create a sustainable livelihood to the informal sectors

**2. Scope:**

- **Municipal corporation** will provide the sustainability solution to **P. Rami Reddy Memorial College of Pharmacy** for responsible disposal of recyclables.
- Pickup request for disposal of material will be generated on **P. Rami Reddy Memorial College of Pharmacy**. Required services will be fulfilled recycle and its associated partners.
- While this agreement is in force, **P. Rami Reddy Memorial College of Pharmacy** shall ensure that all the solid recyclables will be disposed only through its associated partner
- Rates for recyclables will be displayed time to time on recycle
- **P. Rami Reddy Memorial College of Pharmacy** will rise involves of the value to be received against the disposal of recyclable.
- The sustainability certificate for responsible disposal through the municipal corporation will be provided and the same can be accessed.
- **P. Rami Reddy Memorial College of Pharmacy** is required to provide necessary entry and exist permissions included, but not restricted to gate-pass, other access

formalities to use its space for loading of recyclable and man power movement during the time of pickup.

The project shall be valid and can be renewed for additional periods and quantities as per mutual agreement of **P. Rami Reddy Memorial College of pharmacy**

### 3. Indemnity:

**P. Rami Reddy Memorial College of Pharmacy** shall be solely responsible for collection and storage of category wise recyclables in their premises.

Municipal corporation will take an initiative to conduct awareness drives with students in the college.

### Term:

This agreement shall come into force from the date of signing and remain valid for a period of 36 months, including final payment and documentation whichever is earlier unless terminated earlier by the parties. The Agreement may be extended for such further periods and quantities as may be agreed to by the parties


**Amendment:** Any Amendment to this agreement shall be valid and binding on the parties only if it is made in writing and signed by duly authorized representatives of each party
